A LOOK BACK, FLOOD UPDATE

In April of 2019, this city suffered from major flooding on McKay Creek that impacted 63 residential homes and caused an estimated \$8.75M in damage. This was the third major flood on McKay Creek in 30 years. In February of last year, the Umatilla River flooded having much greater damage to private property and impacts on human lives.

The City continues to work with the County and other partners to fully recover from and protect against future flooding. We are examining our emergency response plans to improve our response to flooding, the next time this occurs. We are removing bottlenecks in McKay Creek to expand capacity for the creek to convey water and reduce the risk of flooding homes this Spring.

We are also working together to repair the damage done to the creek by the 2019 flood. Repairs include the “armoring of the banks” and making sure that the creek has the same capacity to move water, which has been reduced since the floods. Exposed stream banks make the stream susceptible to erosion which alters the stream channel. While this is a natural part of a healthy stream, we must protect against damages to private property. Our plan is to have these repairs completed within approximately 3 years.

The Umatilla River is a free-flowing stream and flooding occurs as unusual weather patterns occur. McKay Creek has a dam. McKay Reservoir Dam is operated by the US Bureau of Reclamation and was constructed to provide irrigation water, by holding water back to be released when needed by the farmers. It had the additional value of regulating stream flows during the spring runoff to protect private property owners below.

Decades ago, property owners created the McKay Creek Water Control District. The district is funded by property taxes and its purpose is to maintain the capacity of the creek to safely convey the irrigation water and protect against property damage. The reservoir is fed by springs and snowpack in the Blue Mountains. The creek eventually dumps into the Umatilla River in Pendleton. There is approximately 4.75 miles from the dam to the Umatilla River.

Recently, McKay Creek was listed as “critical habitat” for endangered fish. This listing virtually eliminated the ability of the district to maintain the creek as it previously had. Among other causes, we believe that the inability to do this annual maintenance has thrown the system out of balance, resulting in increased risk of flooding.

We are attempting to reduce the risk of future flooding, while maintaining the needs for irrigation water and the environment, by completing a basin study that would identify projects or processes that would enable these important functions to coexist with the protection of homes and private property. We hope this basin study will be funded by FEMA.

We realize we cannot guarantee that flooding will never happen again, but the City feels it is critical we commit to reducing the frequency and being better prepared when it does.

FLOOD RISK UPDATE

Pendleton, Ore. — The City of Pendleton is performing daily monitoring of the conditions which could lead to flooding along the waterways inside the City.

There is currently no flooding predicted in the foreseeable future.

Given the amount of snowfall we received over the past several days, it is likely we will see local flooding of streets caused by melting snow overwhelming the City's stormwater systems. Citizens can help by clearing storm drainages.

SIGN UP FOR ALERTSENSE

City of Pendleton is using a comprehensive emergency alert and notification system powered by AlertSense.



- Emergency Alerts
- Severe Weather Warnings
- Community Notifications

AlertSense enables us to issue emergency alerts to warn citizens of events such as severe weather, fire, flooding, hazardous materials, need for immediate evacuation, civil danger, local area emergencies, and missing persons. The AlertSense platform also enables us to issue service alerts containing critical information from the City of Pendleton regarding temporary utility service interruptions, street closures, and project updates.


This service is provided free to our residents and is easy to sign up. Anyone in City of Pendleton and surrounding areas can register to receive these messages.

We urge all individuals and businesses to register to ensure that we can alert you in the event of an emergency, or temporary interruption of service that could impact you and your family.

Sign up today [HERE](#) and share the types of emergency alerts, severe weather warnings and community notifications that you would like to receive, as well as your contact information and preferences (eg: text message to your cell phone, email, call to your land line phone number). Registration is especially important for those who use a cellular phone or VoIP phone as their primary number, have an unlisted phone number, or who have changed their phone number or address within the past year.

In order to receive personally relevant alerts and notifications, enter your home or work address so that we can send geographically targeted messages. Any information you share will remain private and will only be used to deliver the emergency alerts and community notifications to which you subscribe.

Emergency alerts sent from City of Pendleton, Oregon will come through with the following Caller ID displayed: (541)-215-4610. If you would like to hear the last alert you received repeated, simply dial the Caller ID number back.
