## **DEALING WITH THE HOMELESS IN PENDLETON**

When I talk with civic groups about the homeless, I tell our citizens that if Pendleton can "solve" the homeless problem, we will be the only city in America that has been able to do so. The City Council has made the decision that we are not going to spend a lot of taxpayer dollars on services to the homeless. We have several non-profit and faith-based organizations that serve meals, staff a warming station, and provide services to our homeless. CAPECO is in the process of turning a local motel into transitional housing so that the homeless who want to get a job and get off the streets can have a temporary home until they can provide for themselves.



Recently, City representatives met with a group of concerned citizens to discuss ways that we could work together on trying to manage the negative effects of homelessness. While I

have discussed this in a previous newsletter, let me take a moment to talk about certain legal rights that the Courts have affirmed. In two Federal District Court cases from the cities of Boise and Grants Pass, the Courts established that the homeless have a right to be homeless, and they have a right to have a public place to rest. In the Grants Pass case, the Court declared that the strict anti-camping law was unconstitutional and that the city had to provide the homeless with a place to rest. In response, the City of Pendleton passed an ordinance that said our homeless could sleep on public property from 10:00 pm to 6:00 am but could not establish a campsite. Tents and bedding must be taken down and packed away by the next morning. We made it clear that camping in parks (including the river walkway) is still illegal and that homeless camps will be removed. The homeless are not allowed to block the public right of way. A subsequent law passed by the Oregon Legislature says we cannot confiscate the property (camps) of the homeless until they have been warned and 72 hours pass.

None of these laws restrict private property owners from keeping anyone off their property. If you are a property owner and want to keep the homeless from sleeping or camping on your property, please call the Police Department and tell them you want to post a trespass notice. In my many discussions with our citizens about the homeless, I have discovered a reluctance in citizens to simply call the police to report disturbing behavior. If someone is sleeping on the river walkway or in a park, please pick up the phone and call the police department. If someone is violating your trespass notice, call the police. In this year's budget, the City has provided funding for two new police positions, and Chief Byram intends to establish a new patrol beat in the center of Pendleton that would cover the areas, including the river walkway, where most of our homeless are concentrated. Hiring difficulties and the training pipeline will probably keep this from happening for a year.

You can help by volunteering to sponsor a segment of the river walkway, a park, or a street and by picking up trash in that segment. Call Liam Hughes at Parks and Rec to discuss how you might do this. Report to the police all RVs, cars, or trailers parked on public roads for longer than the 14 days allowed and that appear to house homeless people. Don't assume that all crime in Pendleton is caused by the homeless. During the recent Music Fest weekend, several businesses were tagged with graffiti. The police later caught the offenders, and it turned out they were people known by the police and not part of the homeless population. Because mental illness and drug abuse are common among the homeless, let our State and Federal elected representatives know that we need to provide better mental health services to our citizens, and we need to fix the shortcomings of Measure 110 which has had the unintended effect of increasing illegal drug use.
