THE DEFENDANT REPRESENTS THE FOLLOWING TO THE COURT:

1. My full and true name is \_\_\_\_\_.
2. It is my desire to plead GUILTY to the charge of \_\_\_\_\_.
3. I understand that I may plead NOT GUILTY to any offense charged against me. If I choose to plead NOT GUILTY, the Constitution of Oregon and the United States guarantees me:
  - A. The right to a speedy and public trial by jury;
  - B. The right to see, hear and face in open Court all witnesses called to testify against me;
  - C. The right to use the power and process of the Court to compel the production of any evidence, including the attendance of any witness in my favor;
  - D. The right to have the assistance of a lawyer at all stages of the proceedings;
  - E. The right to take the witness stand, and if I do not take the witness stand, I understand that the jury will be told that this may not be held against me.
4. I know that if I plead GUILTY, the Court may impose the same punishment as if I had plead NOT GUILTY, stood trial and been convicted.
5. I know that if I plead GUILTY to this charge, the maximum possible sentence is \_\_\_\_\_ days \_\_\_\_\_ months imprisonment and/or a maximum fine of \$\_\_\_\_\_. I know that the sentence is up to the Court.
