QUESTIONS RECEIVED:

- 1. Question: Would you consider Quadex Structure Guard an acceptable High-Build Epoxy Coating for this project?
 - a. Answer: Quadex Structure Guard is allowable for use under Section 33 01 30.81 2.2.C Resin Based Spray on Liner.
- 2. Questions: Would you consider Raven 405 in place of SprayRoc? Is this acceptable?
 - a. Answer: Raven 405 is allowable for use under Section 33 01 30.81 2.2.C Resin Based Spray on Liner.
- 3. Questions: Instead of Quadex, we would like to propose SikaQuick VOH. Is this acceptable?
 - a. Answer: SikaQuick VOH is allowable for use under Section 33 01 30.81 2.2.B Cementitious Compound.
- 4. Questions: Is the injection grouting curtain grouting?
 - a. Answer: Section 33 01 30.81 Sanitary Sewer Manhole Rehabilitation Part 3.6A requires each manhole receive full circumferential grouting of all inlets, all outlets, and all joints including base to barrel, barrel to barrel and lid. Section 33 01 30.81 Sanitary Sewer Manhole Rehabilitation Part 3.6B active infiltration also be stopped with surface repair and injection grouting. The project is generally to clean, patch and inject chemical grout as a curtain grout to stop and prevent infiltration and inflow into manholes.

BID DOCUMENTS - PLANS/SPECIFICATIONS - CLARIFICATIONS/REVISIONS:

1. Section 33 01 30.81 Sanitary Sewer Manhole Rehabilitation – Delete Part 3.6 in its entirety and replace with the following:

"3.6 INFILTRATION CORRECTION

A. Full circumferential injection grouting of all inlets, all outlets, and all joints including base to barrel, barrel to barrel and lid. Drilling shall be required in order to pressure grout outside the structure using chemical grout. Manufacturer's recommendations shall be followed for pressure grouting. A sufficient amount of product and injection ports shall be applied to stop all inflow. No protruding injection material shall be allowed. Injection material protruding into manhole shall be removed flush with the manhole interior wall surface.

- B. Any leaks shall also receive injection grouting to stop the leak. Minor leaks shall also be stopped using the quick-setting specially formulated infiltration control mix and shall be mixed and applied per manufacturer's recommendations.
- C. Any infiltration or leaks must be stopped for a minimum 24 hour period prior to application of spray on liner."
